# 4. Minutes of the previous meeting held on 04 February 2020

The minutes had been circulated to councillors prior to the meeting and it was **proposed** that they are signed as a true and accurate record of the meeting.

The Council **RESOLVED** to accept the proposal with the addition of the planning application number in item 8d; the Chairman signed the minutes.

## 5. Chairman's Announcements

#### 6. Open Session

The Chairman asked for a member of the public to be a spokes person then for others to follow with additional points

- Simon Johnson outlined his case for objecting to planning applications 5093 and 5094 (8a and c on the agenda).
  - Over Development
    - LDNPA policy is for 60 new dwellings per annum across the Park
    - This equates to 12 per annum across 21 villages
    - Development within Crosthwaite is an increasing trend with 37 new buildings since
       2016
    - There are several (15 to 17) other planning applications to come in the near future
    - Crosthwaite has taken a disproportionate share of LDNP village development
    - Other villages average 6 to 8 new dwellings in the same period and need to take up village development
    - There has been grossly disproportionate overdevelopment of Crosthwaite

- Housing Need
  - The LDNPA has a 5 year supply of land for housing
  - This exceeds the requirement of 900 by 181
  - There is no housing need in Crosthwaite
  - The use of windfall sites is unjustified
- Village Amenities
  - There is no shop, no bus, no amenities.
  - There is no pedestrian access to either of these sites (5093 and 5094)
- Application 5094 (8c) Starnthwaite Road
  - is outside the village curtilage, in open country, and is ribbon development
  - There is no evidence that this development meets a need
- Distinctive Area
  - The application requires the removal of dry stone wall and several trees.
  - The distinctive nature of Crosthwaite is under threat
  - Application fails to comply with LDNA Core Strategies CS01, 02, 03, 07, 11, 18, 25
- 23 people applauded these comments
- Mr Graham Paine spoke regarding drainage for both applications
  - The current drainage system for planning application 5093 (8b) Redwood House property is suitable for three dwellings, there are four, and this application would make five.
  - The drainage system is not adequate to service these properties
  - o In planning application 5094 (8c) the bio treated sewage is due to flow into a watercourse which runs through the speakers garden
  - o This watercourse runs intermittently and last summer dried up for six weeks
  - o This means there will be no natural flow to flush away the sewage outfall
  - Planning law requires an increase in bio diversity and neither of these do that, they in fact decrease bio diversity
  - Site lines for Highways on both sites are poor and will require work to improve, thus removing trees and a dry stone wall
  - 23 people applauded the above statement
- Ian Tomlinson
  - He endorses all that has been said and pressed the Council to refuse both applications 5093 and 5094
  - LDNPA Planning states that previous application in Crosthwaite have had numerous objections
  - It is time for the Parish Council to be in dialogue with the LDNPA planning to state the view that Crosthwaite needs to retain its distinctiveness
  - o 23 applauded these comments
- Alan Gerrard
  - He asked that the Parish Council makes every effort to communicate the feelings of parishioners to LDNPA
- The Chairman asked for a show of hands of those objecting to planning application 5093 and 5094 (items 8b & c) on the agenda
  - 24 people raised their hands
- Mr Whitehurst, the applicant
  - o He has lived in the village for many years and owns 40 acres of land in the parish
  - These applications are for the next stage of his life as he wishes to remain in the village
  - Understands the concerns of parishioners but feels this is a valued development
  - o These applications are not speculative but for a home
- Martin Casson
  - o Regarding planning application 5011, this is a very large shed in a small field (3acres)
  - o It will be very visible, and unsightly, when driving north along the A5074, valley road

- Access onto the highway will not be good as it is on a blind bend, often taken at speed by drivers, and not suitable for agricultural vehicles
- O What is the justification for this building?
- Mr Gregg asked that no parking signs could be put up opposite his house to enable the verge to grown wild flowers. Cty Cllr Jim Bland commented that signs are not permitted. Councillors were supportive a wild flower verge.
