Trees, he had started the process to get the trees around the area for building on to be protected as some were quite old. He also offered his assistance again in supporting a footpath to keep people safer whilst walking to school etc.

He asked the PC to take this all information into account when the plans were sent for approval to the council and the council to be satisfied that Two Castles had answered all these questions.

Mr Tomlinson also discussed the large timber wagons travelling through the village, Cllr Bland informed the PC that the route was an approved route.
